Description Proposal

The overall project is for the realignment of State Highway 2 over the Waikare Gorge and Waikari River near Putorino. The proposal involves the construction of bridges, culverts, roads, underpasses, overpass, wetlands, wetland restoration, stream restoration, earthworks, water diversions and discharges.
